### 4. Old Business

A. Proposed amendments/restatement to the Shoreline Protection Ordinance — Originally sent from Robert LeMay on 12/12/20 and resent by Chris Willoughby with changes by Seth McCormick on 2/19/21. Most recent version sent from Chris Willoughby on 3/12/21.

The Board discussed changes/amendments to the Ordinance. Grammatical, spacing, title adjustments, and definitions were addressed. List of delineators, NOHWM, and types of seawalls were discussed. Links to outside sources that are referenced should be accessible. A google drive account was mentioned as a way to do that.

The Coastal Engineer section was discussed, including approval by Building Commission and the ability of Town to hire its own Coastal Engineer at the cost of the Petitioner as well as the Town reserving the right to get the opinion of another Coastal Engineer if the Building Commission feels the structure is not the minimum necessary to protect the property. Chris Willoughby will make sure this section is not duplicated elsewhere. The process for public notification within 24 hours of the ten-day deadline was discussed.

Chris Willoughby, Bob LeMay, and Seth McCormick will get together again and look at the Ordinance.

- B. Maximum building size 3500 square feet. This item will be discussed at the April 19, 2021 APC meeting.
- C. Solar Ordinance Original proposal sent from Chris Willoughby on 11/15/20. Latest proposal from Seth McCormick sent on 2/14.

The Board discussed the proposed Ordinance that was worked on by Chris Willoughby and Seth McCormick. Seth McCormick explained the Ordinance.

The Board discussed notification by the Town when installation of solar panels is being requested, height of solar panels which Chris Willoughby will look into, setbacks, ground mounted systems, lot coverage with ground mounted systems, view from neighboring properties, roof mounted systems, roof mounted tilting, and this Ordinance in relation to existing Ordinances.

Chris Willoughby, Seth McCormick, Anita Remijas, and Karl Kowalski will work on the Ordinance for the April 19, 2021 APC meeting.
