Meeting Minutes from 02.23.2021  
Long Beach virtual meeting, 6pm

- \* Call to Order 6:02pm Kendra Bartlett, reminder that Park Board meetings take place on the 4th Tuesday of each month, 6pm (go to [longbeachin.org](http://longbeachin.org) for sign in and all other Town of Long Beach information)(email [longbeachparkboard@gmail.com](mailto:longbeachparkboard@gmail.com)).
- \* Quorum: Kendra Bartlett, Zach Neff, Anita Remijas (Joy Schmitt absent)(approximately 3 other participants joined the virtual meeting).
- \* Approval of Minutes from January 2021 meeting, motion Kendra Bartlett, second Zach Neff.
- \* Beach Garden Club Update Janice Brown: Spring is in the air! BGC resumes meetings 04.22.2021 at 1pm (how & where to meet to be decided, adhering to CDC/Town). A particular tree in park by tennis court will be left with 3' of trunk for a fairy garden design. Discussion of how to mesh PB & BGC plans and strategic projects: BGC has funds to do as it wishes; and, PB always welcomes input from community and BGC. Specifically, pathways, walkways, markers, benches, mile markers are up to BGC, working with PB lead Joy Schmitt. Civic Association apparently recently discussed park improvements, specifically benches; and, AR will connect Civic & BGC representatives to discuss in greater detail.
- \* Pickleball/Tennis Courts Rehab Update Anita Remijas: Two pickleball courts on East court (closest to Pavilion), restriping West court for tennis & pickleball, repairing hazardous areas, including at bases of net structures & restriping basketball court. Meeting with Jon Anderson, Arnt Paving, in March 2021, estimates to come hopefully for March 2021 meeting.
- \* Toter Removal/Beach Sign Update Zach Neff: CarryIn/CarryOut policy, toters & corrals are gone, requests to come via Town Council & Park Board for community input re: how to best utilize new spaces (Stops 16, 20, 22, 23, 26, 30). KB will contact Dave to do touch up work where toters & corrals were removed. Invoice for new beach signs will be sent to Clerk DeFuniak, cc JS.
- \* Metal Stair Permit for Stop 20 Kendra Bartlett: Permit approved, weather issue.
- \* Rehab of Stops 21, 23 Zach Neff: Steel vertical poles for stairs necessary, long way to go to be under water again.
- \* Walking Path (park) Proposed by Residents: See BGC update, above. BGC will work with PB liaison JS on this project.
- \* Public Comments: None.
