ORDINANCE NO. 2022- 18

AN ORDINANCE AMENDING ORDINANCE NO. 2021-04 REGULATING GOLF CART USAGE IN THE TOWN OF LONG BEACH, INDIANA

WHEREAS, the Town Council of the Town of Long Beach, Indiana (“Town Council”) previously adopted Ordinance No. 2021-04, regulating golf cart usage within the Town; and

WHEREAS, the Town Council has determined that a bi-annual registration is preferable to an annual registration requirement for convenience and efficiency purposes of both Town staff and golf cart registrants,

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LONG BEACH, INDIANA THAT TITLE VII, CHAPTER 75, SECTION 75.04 SHALL BE AND IS AMENDED AS FOLLOWS:

§ 75.04 GOLF CART REGULATIONS.

The following regulations are established for the operation and usage of golf carts on public streets, roads and alleys in the Town of Long Beach, Indiana, namely:

(A) *Registration fee.* All golf carts used and operated on public streets, roads and alleys in the Town of Long Beach, LaPorte County, Indiana, shall be registered with the Town. Owners shall submit a registration form prescribed by the Town and a \$100 bi-annual registration fee to the Town-Clerk. Once issued, registrations are valid for two (2) calendar years, expiring December 31 of the second (2nd) year. There shall be no prorations for partial years. Upon compliance with registration requirements, the Town or its designee shall issue one (1) three inch (3”) registration sticker, which shall be permanently affixed to the front of the golf cart in a clearly visible location.

(B) *Insurance; proof of insurance; financing responsibility.* All golf carts to be operated and used on public streets, roads and alleys in the Town of Long Beach, LaPorte County, Indiana, shall be insured, with said proof of insurance to be provided at the time of registration. Insurance proof shall be maintained and kept in a golf cart at all times during any usage and operation of such golf cart.

This Ordinance shall take effect, and be in full force and effect, from and after its passage and adoption by the Town Council of the Town of Long Beach, LaPorte County, Indiana, and publication, if any, all in conformance with applicable law.

The Sections of this Ordinance shall be codified and made part of the Town Code of Ordinances and all sections and subsections may be renumbered or re-lettered as necessary to achieve such purpose.

It is the intent of the Town Council that if any section, subsection, sentence, clause or phrase or provision of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not be construed to render invalid or unconstitutional the remaining provisions of this Ordinance.




