TITLE: Summer Camp Counselor

SUMMARY/OBJECTIVE:

Each Camp Counselor is assigned to a specific group of 10 - 15 child campers. The Counselor monitors and assists the assigned campers throughout the daily scheduled camp activities. Camp activities include arts & crafts, exercise, games, playground sessions, special events, etc. The campers assigned to each Counselor remain the same for the 7-week Summer Camp Program. The Counselors' goal is to create and maintain an atmosphere in which the children have fun being campers

To perform this job successfully, an individual must be able to perform each essential function satisfactorily.
