# TOWN OF LONG BEACH TOWN COUNCIL MEETING @ Town Hall JANUARY 6, 2020 7:00 p.m.

Attending tonight's meeting were council members Bob Lemay, Mary Lou McFadden, Nick Meyer, John Kocher, John Wall as council member and Fire Chief, Clerk-Treasurer Bill de Funiak, Police Chief Bob Sulkowski, Town Attorney Chris Willoughby of Braje, Nelson & Janes, Marilyn Jones & Associates videographer and court reporter; and ALCO TV. There were approximately 18 audience members present. Street Superintendent Tom Dolph was absent.

After the **Pledge of Allegiance**, it was noted that all oaths of office for new council members have been tendered and will be sent to LaPorte Circuit Court Clerk, Kathleen Chroback, by Bill de Funiak.

The meeting began with the election of a council president. Nick Meyer motioned to elect Bob Lemay for president; John Wall seconded; Lemay was elected with a 5-0 vote.

President Lemay welcomed all new members to the council; John Wall, Mary Lou McFadden, and John Kocher.

He also stated that all future meetings of the council, aside from tonight's, would continue on the scheduled second Monday of each month at 7:00 p.m. in Town Hall, 2400 Oriole Trail.

Council decided to add committee reports this evening, not noted on the agenda.

#### Reports were Read:

**Police Department / Police Commission**- Police report for December was read by Chief Sulkowski. There was no Police Commission report to read this evening; next month.

Fire Department/Fire Commission – John Wall gave the report for December and spoke of a new member, Ann Marie Hayes, members that are in training and the 6 new instructors. The fire commission will be meeting in January. The new fire commission will be in the next couple of weeks. Wall spoke of the Town notifying NIPSCO and holding an hour and a half phone conference with their officials, the Town's building commission and Lemay to discuss the urgency of lakefront remediations if actions should be taken regarding a disaster plan on the lake shore with regards to the town's water main, roads, utilities, etc.

**Street Department/Street Commission** – Tom Dolph was absent so no reports were given; report will be given at February's meeting.

Park Board – Kendra Bartlett was present to give a report for the Park Board. There will be free Tai Chi classes at the community center on January 13 and January 27 at 3 pm in the gym. Landscaping is being done at Stops 14 and 18. The next Stop for rehab will be Stop 28; public input is welcome. No new money will be spent on rehabbing stairs that have been washed out until assessments are made in the spring.

**Long Beach Community Center Committee** – de Funiak announced that Joy Schmitt picked up the new plaque delivered to Town Hall for the community center's historical status; it will be displayed on site at the old Long Beach School, now the Long Beach Community Center, 2501 Oriole Trail, Long Beach.

**Water Board** – Nick Meyer mentioned that no report for December; and the board meets on the 4<sup>th</sup> Monday at 9:00 a.m. at Town Hall.

**Budget and Finance** – de Funiak had no minutes for December but January's meeting will take place Wednesday, the 8<sup>th</sup> at 8:30 a.m. in Town Hall; discussion to include the priority list for 2020 – Stop 15, Stop 24, Fire Station, road paving, etc.

**Human Resources Advisory Committee** – Lemay received a survey from A.I.M. (Accelerated Indiana Municipalities) for employee salary positions; he would like the Town to work on a merit-based salary ordinance for Long Beach.

#### Building Department - Byvoets reported on the December 13th meeting.

Mentioned properties at 1802 LSD, Perry -at BZA level; 1906 LSD, Nash- ticket issued; 3010 LSD, Flando residence- with Atty.; 2010 Juneway, septic system without a permit, contractor Sunset Septic & Excavating-taken to court; 2932 Mt. Claire Way-taken to court; All properties in jeopardy along lakeshore drive were discussed and permitted temporary repairs that were given to residents needing emergency attention. 2310 Lake Shore resident who wanted to build a small structure on his property but cannot because of the Town Code requiring a primary structure on the lot will have to have his 2 lots combined into one through the County in order to be permitted. Next meeting will be January 10<sup>th</sup> at 1 PM in room 3 at the community center.

#### Board of Zoning Appeals - Met on December 10th-

1802 LSD, 2027 Oriole Trail, 2809 Lyndale Trail, and 2816 Brentwood Way are all before the Board at this time for variances. Next meeting is January 14<sup>th</sup> at 7 PM in Town Hall.

Advisory Plan Commission - No December meeting held.

A motion was made by Meyer; second by Wall, to accept all reports as presented. Motion carried 5 - 0.

#### Fire Commission -

#### Park Board-

4, all with 4-year terms, appointed by council, no more than 2 from the same party, no council members, only citizens:

Bob Lemay nominated Kendra Bartlett-R (2021), Jerry Massey-I (2022), Zachary Neff-I (2020) and Joy Schmitt-D (2023); second by John Wall.

Mary Lou questioned the council's previous meeting where she asked that Mary Kowalski be on the Park Board; Lemay stated he changed his mind and chose Joy Schmitt. The 4 nominated by Lemay were approved by 4-1 vote.

**Budget and Finance** – Annual appointments to include the Clerk-Treasurer and 4 members appointed by council president:

Clerk-Treasurer, Bill de Funiak, Peter Byvoets, Laurel Kuczynski, Robert Lemay Joe Jogmen

Police Advisory Board- 3 by Council President Lemay and 1 by the Police Chief:

Appointed by Lemay were Dan Moon and Zachary Neff. Joe St. Peter was appointed by Chief Sulkowski. Lemay noted the Advisory Board should meet at least once a year.

**Human Resources-** To be appointed annually by Council President Lemay and to include the Clerk-Treasurer and the police chief:

Appointed by Lemay were Georgetta Cox, and Mike Konicek and Mary Lou McFadden from the council; the other 2 members are Clerk-Treasurer Bill de Funiak and Police Chief Robert Sulkowski.

#### Community Center- To be elected by the council, annually:

Lemay felt he want to add a sixth person to the already 5 members working successfully for the community center. Kocher motioned to elected all 6 together of Lemay's nomination of Mary Carol Lombard, Doug Wickstrom, Joe Jogmen, Horst Bauchrowitz, Joy Schmitt, and the sixth added member, Bob Gallagher. Nick Meyer seconded the motion and all approved 5 – 0.

**NIRPC -Northern Indiana Regional Planning Commission**- Nick Meyer nominated Lemay; seconded by John Kocher, approved 5-0.

#### Land Conservation/Tree Board- Annually appointed by Council:

Lemay nominated Annabelle Juhasz, David Hoppe, Martha Maust, Paul Fithian, Rachel Stadler, and Joy Schmitt, Liason to the APC. He made that into a motion, seconded by Kocher, and approved 5 – 0.

Nick Meyer made a motion to eliminate the Town Beautification committee, second by Lemay, 5-0. De Funiak asked for someone to get the contact information for the members of each committee and submit to the office.

The Committee Lists Submitted by President Lemay are attached to these minutes.

#### Public Comments -

**Council Comments** – John Kocher asked that the council members be given a status report, by Attorney Willoughby, of all litigations still on the books with legal fees; Lemay made a motion that it be a monthly report, second by McFadden, approved 5-0.

Clerk-Treasurer de Funiak noted to the new council the check register he sends to them each month noting major expenditures so they can familiarize themselves with the reports before the month council meetings take place.

John Wall spoke of the one day conference the three newly elected council members attended in Crown Point.

Claims Approval: Checks #16948 through #16957 totaling \$30,774.93; motion to approve by Lemay, second by Wall; 5-0.

The was a question by Kocher on check #16957; de Funiak said it's an invoice by the building commissioner, not always submitted monthly, but sporadically, sometimes more than one a month, but he invoices on a monthly basis.

Motion and second to adjourn by Meyer and McFadden, approved 5-0.
